Brief bio-data

Rahul Pande is one of the youngest State Chief Information Commissioner (Maharashtra) and was also one of the youngest State Information Commissioner who has completed his tenure successfully. During this stint he handled work of Nagpur bench covering Nagpur revenue division comprising six districts of East Vidarbha region. Additionally also had additional charge of Amravati bench (covering five districts of West Vidarbha) since November 1, 2022. After appointment as the State Information Commissioner (Maharashtra) in September 2021, brought vibrancy in the functioning of Information Commission at Nagpur to bring down the pendency. Within two weeks, he was asked the handle Amravati bench as well and discharged the duty for around a month.

From January 12, 2022 was given additional responsibility of Chhatrapati Sambhaji Nagar bench whose jurisdiction is over all districts of Marathwada region and disposed of record number of cases and tried to bring down pendency to manageable limits by tackling district-wise and applicant wise cases pertaining to one authority. The charge remained with him till May 2023 or about 16 months.

As a result from November 2022 till May 2023, Shri Pandel was handling charge of Nagpur, Amravati and Aurangabad benches simultaneously covering entire Vidarbha and Marathwada region. During this period, his disposal rate has been extremely fast and pendency in all the three benches was reduced substantially. Several landmark rulings were delivered during this period Conducted hearings at district places in Vidarbha and also addressed the workshops and seminars on RTI during this period including one at Chandrapur, Wardha, Bhandara and Amravati where a large number of stakeholders including senior government officers participated. Adopted

hybrid and online hearings well before the Hon'ble Supreme Court made it mandatory for Information Commissions' across country. Took active interest in digitization of SIC records and also to improve co-ordination between benches.

During three years disposed of more than 26,000 cases at Nagpur, Amravati and Sambhaji Nagar with reasoned orders which most of the time withstood judicial scrutiny during this eventful tenure. This includes conducting on-line/physical hearing at Nagpur, Amravati and Chhatrapati Sambhaji Nagar benches besides handling administrative works of all the three benches for a considerable period.

During this tenure improved physical infrastructure of all three benches, on-line conference and hearing facility was installed at all the benches, due to pro-active and pro-people initiatives, all the stakeholders including citizens and public authorities have reported satisfaction with the

performance of benches headed by him. The Hon'ble judges (past and present) of Supreme Court of India and High Court have openly and wholeheartedly acknowledged the good work done from public platforms and on administrative and judicial side have specifically mentioned their appreciation.

Till completion of tenure as SIC held additional charge of Amravati bench which covers five districts of Western Vidarbha and regular charge of Nagpur bench which include six districts of East Vidarbha where RTI appeal pendency has drastically came down and direct action against certain undesirable elements who are misusing RTI provisions to extort or blackmail has put in place much needed mechanism to deal with menace of blackmailers.

During his previous stint as the CITY EDITOR of THE HITAVADA at its flagship Nagpur edition and my long stint as a successful journalist working in Central India's largest and oldest English Newspaper, handled very critical responsibilities expected from a senior journalist heading the reporting team with great distinction and to the great satisfaction of the management.

Due to his legal education and vast experience of legal reporting, was fortunate to have direct rapport and personal ties with legal luminaries which gave him an added advantage to learn the law directly from those interpreting it and understand the thought process behind justice delivery system.

As State Information Commissioner, he could handle thousands of cases during last three years and deliver several path-breaking and landmark decisions to make RTI regime more peopleoriented and less cumbersome at the same time I took a serious cognisance of menace of blackmailing carried out by certain unscrupulous elements and made a public appeal to openly complain and register offences against such undesirable people bringing bad name to this sunshine act.

Was selected as Executive Committee member of the Nagpur Union of Working Journalists (NUWJ). Became its Vice-President for two terms and elected as General Secretary of the NUWJ during the year 2007-08. Introduced free health check-up camps, free computer education, skill enhancement, scholarships and fellowships for journalists. Made an aggressive presentation before the Wage Board for Journalists.
